# We Work for You!

Donna Bernardi is your Township Supervisor. Her main responsibilities for the township include being the Treasurer of all town funds, and Supervisor of General Assistance. Since her election she has earned a certificate for continuing education in professional development from the Township Officials of Illinois. This marks her participation in education focused on statutory responsibilities and public service. She is currently also serving as secretary for the McHenry County Township Officials Association.


David Diamond is your Highway Commissioner. He is responsible for the maintenance and repair of Riley Township's forty-seven miles of roads, all the equipment and the road district garage. The road district maintains all roads that are not maintained by IDOT, McHenry County, or the City of Marengo. Due to budgetary constraints, the position of the Highway Commissioner and road district employees are all part-time. They perform essential services such as snow removal, pavement repairs, tree trimming, sign maintanence, mowing and roadside litter pickup. The Highway Commissioners's responsibilities also include preparing the road district budget and levy, issuing all

new driveway permits, supervising all utility construction in the township right of way, attending numerous meetings regarding township road issues and insuring that the interests of Riley Township's Road District are represented.

Karen Schnable is your Township Clerk. Some of her responsibilities include maintaining the records throughout the year. Other responsibilities such as those relating to the annual town meeting arise once a year. The Township Clerk is also the Clerk for the Road District. She processes the Road District's bills and prepares a report that is presented to the Town Board for approval on a monthly basis.

Your Tax Assessor is Barbara Rooney. She has successfully completed all the necessary schooling for her C.I.A.O. (Certified Illinois Assessing Official) and continues her education in the assessing field every year by taking two classes over the summer months.

Trustee Pat Grimm has been a servant to our community since 1985 when she held the Clerks position until her retirement from office in 1996. She decided to return to public service as a Trustee in 1997. She is also the



Business Manager and a Bus Driver for Riley School since 1982.

Doug Kunde is one of the three newly elected Trust-ees last spring. He is an active member of St. Johns United Church of Christ in Harmony, serving on the Propoerty and finance committee for the church.

Besides being a Trustee, Jim Gibbons also serves as a Member of the New Marengo High School Committee, The General Advisory Committee at Marengo High School. He serve as Extraordinary Minister at Scared Heart Church and is also a member of the Township Officials Association of McHenry County.

Before Arlene Genell was voted into the position of Trustee, she served Riley Township as the Chair of the Riley Plan Commission. As a member of the Plan Commission she helped formulate the Riley Land Use Plan- 2000. She brings with her experience earned as an elected official of Lake County, former Chair of Governor Edgar's IL Advisory Council for Head and Spinal Cord Injury, and Board member of the American Cancer Society. She is also a active member of Sacred Heart Church in Marengo.

# Tips from Assessor Rooney

Are you "aware of a few exemptions that you, as a tax payer, may be qualified for?"

E R I would like to make you as a taxpayer aware of a few exemptions that you may be qualified

The Homestead Exemption would qualify you for a DIS-COUNT of \$3,500 off the equalized assessed value of your home provided you meet the following criteria. The house must be owner occupied and having a legal, equitable interest in the property; be a single family residence; cooperatives - owner liable for taxes by contract or, life care facility-owner liable for taxes by contract.

There is also what is called the Senior Citizens Homestead Exemption. This enables you to \$2,000 off of your equalized assessed value times the tax rate. First time applicants must complete the appropriate application, provide proof of age, and provide a copy of a document showing your

name, legal description and the legal or equitable interest in the property i.e., warranty deed, title policy, etc.

If you feel you qualify for any of the above exemptions, check your tax bill to see if you are receiving them. If you are qualified and are not receiving the appropriate exemption please feel free to contact me at (815) 568-8326 and leave a message with your call back telephone number.

# News "Flash"



Undoubtedly, we have all driven through the intersection of Route 23 and Pleasant Grove/Coral Roads. I am sure most of us thought about the extreme danger this intersection presents. Essentially an intersection on a curve, it is nearly impossible to gain a clear perspective when traveling any direction but east.

After becoming Highway Commissioner, I did some investigating into why additional safeguards had never been installed at the site. In September, 2000 I contacted IDOT and State Senator Dick Klemm about my concerns. Senator Klemm took immediate interest and IDOT responded that their Traffic counts in June of 2000 averaged just under 300 cars an hour and that did not warrant any intersection safety improvements.

After receiving that information, I again contacted IDOT and requested their criteria on installing a flashing amber beacon. They responded that there were "no specific traffic count requirements to warrant such an installation." Again I called upon



Senator Klemm and State Representative Rosemary Kurtz as well and requested their assistance in getting a flashing amber beacon installed at the intersection advance signs. Senator Klemm contacted Matt Davidson of IDOT's Springfield headquarters. In the summer of 2001 Mr. Davidson met with me at the intersection and we discussed the safety concerns present there.

Following the meeting, numerous calls to Springfield were made. Finally last fall I received word from Senator Klemm's office that the project had been approved and it would begin some time over the winter. The flashing lights were activated for the first time on March 11, 2002.

I wish to extend Riley Township's sincere thanks to Senator Klemm, his assistant Geri Davis, State Representative Kurtz, and Matt Davidson of IDOT. The combined assistance of these individuals will make a significant improvement toward safe driving in Riley Township.


